**RE: Authorization Letter for PROFIMPORT LLC**

This letter is to confirm that PROFIMPORT LLC, Russia (“Profimport”) is a licensee of The Goodyear Tire & Rubber Company (“Goodyear”), Akron, Ohio, USA, pursuant to the agreement dated August 08, 2016.

As a Goodyear licensee, Profimport has been granted rights to produce, distribute, advertise and promote, the following category of products bearing Goodyear trademarks:

- (i) Car accessories consisting of car mats, ratchet tie downs, tow ropes, radio antennas, battery cables, air compressors, snow chains, snow shovels, roof bars, recovery tracks, car wash accessories consisting of cleaning kits, cleaning wipes and cloths, wiper blades, window deflectors, spoilers, flexi blade/squeegee, snow brush, ice scrapers, car jacks, phone and PDA holders, AC and 12V/24V power socket converters, chargers and adaptors, slip proof mats to hold objects on the dashboard, car vacuum cleaners, battery booster packs, battery chargers, jump starters, mechanic and driving gloves, tire gauges, FM transmitters, seat covers, drink holders, car covers, car organizers, steering wheel covers, petrol funnels, tire bags, air fresheners, seat covers, cushions and pillows, blankets, coolers and warmer boxes, reflective vests, cosmetic covers and decorations for vehicle components (i.e. pedals, stripes, gear shifts, petrol caps and wheel covers), high pressure washers (consumer type only), roadside assistance kits (which specifically include the following items which cannot be sold separately: booster cables, tow ropes, warning triangles, safety vests, gloves, emergency hammers, long nose pliers, wrenches, bits, tape, cable ties, flash lights and bags), sponges, and waxing cloths;
- (ii) Car lights consisting of bulbs, headlight bulbs, fog light bulbs, tail light bulbs, led headlight conversion kits, turn signal bulbs, interior light bulbs, led light bulbs, exterior light bulbs, automotive led lights, led daytime running lights, led strips and tubes, led headlights, work and flash lights, halogen bulbs and xenon bulbs;
- (iii) Car repair products consisting of air filters, oil filters, fuel filters, and automotive fuses;
- (iv) Car care products consisting of car waxes, windscreen washer fluid, car wash liquids, glass cleaning liquids, leather cleaning liquids, dashboard cleaning liquids and polishing waxes, lock defroster and tire foam;
- (v) Hand tools consisting of bits, screw drivers, clamping tools, pliers, spanners, hammers, saw racks, wrenches, bolt drivers, tool boxes, filers, torque wrenches, tool kits, tool vests, tool waist belts, working gloves, bolt cutters, clamps, crimping pliers, hand riveters, pipe cutters, pocket folding keysets, scrapers, screwdrivers, socket and ratchet sets, spirit

- levels, tool box sets, torques and hexagonal key sets, knife cutters, hand saws, and multifunction pliers with knife;
- (vi) Power tools consisting of bench grinders, routers, impact drills, hammer drills, cordless drills, cordless drills with bits (set), bench drills, electric drills, electric screwdrivers, orbital sanders, belt sanders, polishers, polisher kits (set), air tool kits, electric shears, drywall sanders, paint rollers, wallpaper stripper and steam cleaners, electric mixers, glue guns, drill bit sharpeners, soldering guns, spray guns, heavy duty air ratchets, wrenches, marble and jig saws without blades, hot air guns, blowers, power generators, impact wrenches, electric screwdrivers;
  - (vii) Batteries consisting of Car 6V and 12V batteries; and
  - (viii) Windshield wiper blades with standard, flat or hybrid technology and replacement blades to be sold in the replacement equipment market.

Profimport is authorized to sell Goodyear branded licensed products in Russia, Belarus, Ukraine, Armenia, Azerbaijan, Kazakhstan, Kyrgyzstan, Moldova, Tajikistan, Turkmenistan, Georgia and Uzbekistan until December 31, 2021, (unless terminated earlier pursuant to the terms of the agreement).
